Lack of access to housing, education, training, job opportunities, and public benefits have created conditions that make successful reentry into community nearly impossible for millions of our neighbors who have served time in prison. These obstacles essentially deny them the opportunity to become the kind of engaged, responsible citizens we claim to desire.
