Why Reform is Needed

Formerly incarcerated persons face a myriad of barriers that deny them the opportunity to become the kind of engaged, responsible citizens we claim to desire. Conditions in our prisons add to the problem. Punitive and extended use of solitary confinement creates or exacerbates mental health conditions for those who receive it. Health care is often lacking. Mandatory minimums have caused thousands of non-violent (primarily drug) offenders to spend years in prison, making reentry after release more difficult. Little is done to prepare incarcerated persons for reentry.

Advocates recently achieved success with passage of "Clean Slate" legislation that would automatically seal from public uses the records of persons with minor, non-violent misdemeanor convictions if they have remained conviction free for at least 10 years, as well as records on arrests that do not lead to convictions. But there is so much more that needs to be done.

Gun violence continues to be a problem in Pennsylvania as well. A number of bills have been proposed over the years to require better background checks, reporting of lost and stolen guns, purchasing limits of one gun/month, and banning of assault –style weapons and bump stocks. It has been difficult even to achieve small gains in very specific areas—like limiting gun access for domestic abusers.

People of faith from all points on the theological spectrum are supporting common sense legislation to address these issues, and benefit from knowing how to advocate effectively for the change they desire.

Why You Should Attend

Come to this program to learn why, as people of faith, we engage in advocacy—in broad terms, but with emphasis on why from an Anabaptist perspective. Come to learn more about this important legislation and why it is so important that people of faith support a bill that opens doors for our brothers and sisters who have served time. Come to learn how Pennsylvania governing structures work, and how to engage with your legislators and policy makers to support "Clean Slate." Then join with your neighbors to visit your Representatives to make the case for its passage.
