A number of bills have been proposed over the years to require better background checks, reporting of lost and stolen guns, purchasing limits of one gun/month, and banning of assault —style weapons and bump stocks. It has been difficult even to achieve small gains in very specific areas—like limiting gun access for domestic abusers.
